You must be 16 years of age or older at the date of entry. If you are between 16-18 years old, you must have a parent or guardian's permission before entering.

You may submit only one entry. Submitting more than one entry will disqualify you.

Your entry becomes the property of the Lovis Foundation. We reserve the right to post your entry or online or in other forms. Materials will not be returned.

This is a contest of skill. Whether or not your entry is determined as a winner depends on how your entry compares to the other entries submitted in the ETA Rising Star Award Contest when evaluated.

By entering this contest, you agree to the following terms:

In consideration for the opportunity to submit my Entry to participate in the ETA Rising Star Award Contest, I give the Lovis Foundation and its agents and contractors the right and permission to use, copy, alter, distribute, publish, broadcast, and display materials I have submitted; photographs and images of me that I have provided or that they will create; my voice and likeness; my name; the city, state, or province in which I live; and other information and material included in my Entry, on the Lovis Foundation website, elsewhere on the Internet, in advertising and promotional materials, and in any other medium or format for any purpose related to the Lovis Foundation.
